2014 THEMES:

(choose one of the following)

- Currently, in Ohio, water quality and nutrient management are at the forefront of environmental concern. What are the problems and causes? What can be done to restore and preserve our state's waters?
- Texting while driving recently surpassed drinking and driving and sleeping while driving as the number one causes of traffic fatalities in Ohio. Aside from passing a law to prohibit this activity, what can be done to reverse this trend.

The essay must be typed, double-spaced, 1-inch margins, 12-point font, and be 500 to 1,000 words in length. Contestants must not reveal their identity on the essay. This is to ensure "blind review" by the judge. It must be accompanied by an application which can be obtained from Ohio Farmers Union by calling 800-321-3671 or email lborton@ohfarmersunion.org.

ELIGIBILITY: Any member of Ohio Farmers Union who is a high school junior or senior or enrolled as a college freshman is eligible to apply. Applicants need not have a membership in their own name if their parents or grandparents are members.

JUDGES: All submitted essays will be judged by educational professionals not associated with Ohio Farmers Union.

ENTRY DEADLINE: Ohio Farmers Union application and essay must be postmarked by December 31, 2013.

JUDGING CRITERIA: All essays will be judged on:

50% Creativity
25% Topic Development
25% Presentation

The three (3) finalists will present their essays during the Ohio Farmers Union 80th Convention. The winner will be announced at the conclusion of the convention.

The scholarship is \$1,000 to the winner and \$250 to two runners-up. The award is paid to the winner and the winner's choice of institution of higher learning at the time of enrollment.
